1. The Government of the United Republic of Tanzania has set aside funds for the operation of the NATIONAL IRRIGATION COMMISSION during the financial year 2024/2025. It is intended that part of the proceeds of the fund will be used to cover eligible payments under the contract for the Provision of Consultancy services for Feasibility Study and Detailed Engineering Design of 18 Irrigation Schemes in Mwanza Region.
2. The NATIONAL IRRIGATION COMMISSION now invites eligible consultants to submit proposals for the following consulting services: Provision of Consultancy services for Feasibility Study and Detailed Engineering Design of 18 Irrigation Schemes in Mwanza Region. Details of the services are provided in the Terms of Reference.
3. The NATIONAL IRRIGATION COMMISSION now invites proposals from GOVERNMENT\_ENTERPRISE, Civil Society Organization, Company Local, Company Foreign, Special Group, Partnership Local and Partnership Foreign to indicate their interest in providing the services which include Provision of Consultancy services for Feasibility Study and Detailed Engineering Design of 18 Irrigation Schemes in Mwanza Region for a duration of 180 days.
4. A firm will be selected under Quality and Cost Based Selection and procedures described in this RFP.

	1.2	Only the short-listed Consultants indicated in the Letter of Invitation are to submit a Proposal for the provision of Consulting Services required for the assignment. The Proposal will be the basis for contract negotiations and ultimately for a signed Contract with the selected Consultant.
	1.3	The successful Consultant will be expected to complete the delivery of the Services in accordance with the phasing indicated in the <b>PDS</b> . When the assignment includes several phases, the performance of the Consultant under each phase must be to the PE's satisfaction before the commencement of the next phase.

2. Source of Funds	2.1	The PE has allocated public funds as indicated in the <b>PDS</b> and intends to apply a portion of the funds to eligible payments under the contract for which this RFP is issued.
	2.2	For the purpose of this provision, “public funds” means monetary resources appropriated to PEs as defined in the Public Procurement Act, Cap 410.
	2.3	Payments by the development partner, if so indicated in the <b>PDS</b> , will be made only at the request of the Government and upon approval by the development partner in accordance with the applicable Loan/Credit/Grant Agreement, and will be subject in all respects to the terms and conditions of that Agreement.
3. Corrupt, Fraudulent, Collusive or Coercive Practices	3.1	The Government requires that PE, as well as Consultants, to observe the highest standard of ethics during the implementation of the procurement proceedings and the execution of contracts under public funds.
	3.2	<p>In pursuance of this requirement, the PE shall</p> <ul style="list-style-type: none"> <li>(a) exclude the Consultant from participation in the procurement proceedings concerned or reject a proposal for award; and</li> <li>(b) declare the Consultant ineligible for a stated period of time, from participation in procurement proceedings under public fund;</li> </ul> <p>if it, at any time, determines that the Consultant has, directly or through an agent, engaged in corrupt, fraudulent, obstructive, collusive, coercive practices in competing for, or in executing, a contract under public fund.</p>
	3.3	Should any corrupt, fraudulent, obstructive, or coercive practices of any kind referred to in ITC 3.4 come to the knowledge of the PE, it shall, in the first place, allow the Consultant to provide an explanation and shall, take actions as stated in ITC 3.2 only when a satisfactory explanation is not received. Such exclusion and the reasons thereof, shall be recorded in the record of the procurement proceedings and promptly communicated to the Consultant concerned. Any communications between the Consultant and the PE related to matters of alleged fraud or corruption shall be in writing or in electronic forms that provide record of the content of the communication.

	3.5	The Consultant shall be aware of the provisions on fraud and corruption stated in <b>GCC3</b> [Corrupt, Fraudulent or Coercive Practices] and <b>GCC66.3</b> [Termination for Default].
	3.6	The Consultant's and the PE's personnel have an equal obligation not to solicit, ask for and/or use coercive methods to obtain personal benefits in connection with the said proceedings.
4. Eligible Consultants	4.1	Only short-listed Consultants are eligible to submit proposals. In the case of a <b>JVCA</b> , all members shall be jointly and severally liable for the execution of the Contract in accordance with the Contract terms. The <b>JVCA</b> shall nominate a Lead Member who shall have the authority to conduct all business for and on behalf of any and all the members of the <b>JVCA</b> during the selection process and, in the event the <b>JVCA</b> is awarded the Contract, during contract execution. The Lead Member shall at the time of contract award confirm the appointment by submission of a Power of Attorney to the PE.
	4.2	Any proposal from a <b>JVCA</b> shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated or post qualified with respect to its contribution only and the responsibilities of each party shall not be substantially altered without prior written approval of the PE.
	4.3	The Consultant shall not be under a declaration of ineligibility for corrupt, fraudulent or coercive practices in accordance with ITC3 [Corrupt, Fraudulent, Coercive and Collusive Practices].
	4.4	Government or semi-public agencies in the United Republic of Tanzania may participate only if they are legally and financially autonomous, if they operate under commercial law, are registered by the relevant registration board or authorities and if they are not a dependent agency of the Government.
	4.5	Foreign firms competing to be awarded non-emergency consultancy assignments whether by tender or any other means recognized in Public Procurement Act Cap 410 shall be required to include local experts and firms in their teams. Appropriate weights shall be assigned by PE in the <b>PDS</b> so that they are used during evaluation.
	4.6	Consultants may be ineligible if – <ul style="list-style-type: none"> <li>(a) such person or firm is declared bankrupt or, in the case of company or Consultant insolvent;</li> <li>(b) payments in favour of the person, company or Consultant is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting, in accordance with the national laws, in the total or partial loss of the right to administer and dispose of its property;</li> <li>(c) legal proceedings are instituted against such person, company or Consultant involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property;</li> <li>(d) the person, company or Consultant is convicted, by a final judgment, of any offence involving professional conduct;</li> <li>(e) the person or Consultant is debarred and blacklisted in accordance with Public Procurement Act from participating in public procurement for corrupt, coercive, fraudulent, collusive or obstructive practices, breach of a procurement contract, failure to abide with Bid Securing Declaration and making false representation about his qualifications during selection proceeding or other grounds as may be deemed necessary by the Authority;</li> </ul>

	4.6	The Consultant has fulfilled its obligations to pay taxes and social security contributions under the relevant national laws and regulations.
	4.7	Government officials and civil servants, including persons of autonomous bodies or corporations may be hired to work as a member of a team of consultants provided the person (a) is on leave of absence without pay; (b) is not being hired by the PE he/she was working for immediately prior to going on leave; and (c) the hiring of him/her would not create any conflict of interest.
	4.8	Consultants have an obligation to disclose any situation of actual or potential conflict of interest that impacts on their capacity to serve the best interest of the PE, or that may reasonably be perceived as having this effect. Failure to disclose such situations may lead to the disqualification of the Consultant or the termination of its Contract.
5. Conflict of Interest	5.1	<p><u>General</u></p> <p>The Consultant (including any of his affiliates/associates), in reference to the requirements that the Consultant provides professional and objective advice and at all times hold the PE’s interests paramount, strictly avoids conflicts with other assignments or their own corporate interests, acts without any consideration for future work and must not have a conflict of interest (COI), shall not be recruited under any of the circumstances specified in ITC 5.2 to 5.4 below. “COI” shall mean a situation in which a Consultant provides biased professional advice to a PE in order to obtain from that PE an undue benefit for himself or affiliate(s)/associate(s).</p>
	5.2	<p><u>Conflicting Activities</u></p> <p>A firm that has been engaged by the PE to provide Services, works or services other than consulting services for a project, and any of its affiliates, shall be disqualified from providing consulting services related to those Services, works, or services. Conversely, a firm hired to provide consulting services for the preparation or implementation of a project, and any of its affiliates, shall be disqualified from subsequently providing Services or works or services other than consulting services resulting from or directly related to the firm’s earlier consulting services. For the purpose of this clause, services other than consulting services are defined as those leading to a measurable physical output, for example surveys, exploratory drilling, aerial photography, and satellite imagery.</p>
	5.3	<p><u>Conflicting Assignments</u></p> <p>A Consultant (including its Personnel and Sub-Consultants) or any of its affiliates shall not be hired for any assignment that, by its nature, may be in conflict with another assignment of the Consultant to be executed for the same or for another PE. For example, a Consultant hired to prepare engineering design for an infrastructure project shall not be engaged to prepare an independent environmental assessment for the same project, and a Consultant assisting a PE in the privatization of public assets shall not purchase, nor advise PEs of, such assets. Similarly, a Consultant hired to prepare Terms of Reference for an assignment shall not be hired for the assignment in question.</p>
	5.4	<p><u>Conflicting Relationships</u></p> <p>A Consultant (including its Personnel and Sub Consultants) that has a business or family relationship with a member of the PE’s staff may not be awarded a Contract, unless the conflict stemming from this relationship has been addressed adequately throughout the selection process and the execution of the Contract.</p>

	5.5	<p><u>Unfair Competitive Advantage</u></p> <p>Fairness and transparency in the selection process require that the Consultants or their Affiliates competing for a specific assignment do not derive a competitive advantage from having provided consulting services related to the assignment in question. To that end, the PE shall indicate in the <b>PDS</b> and make available to all shortlisted Consultants together with this RFP all information that would in that respect give such Consultant any unfair competitive advantage over competing Consultants.</p>
6. Eligible Services	6.1	All material, equipment and supplies used by the Consultant and Services to be provided under the contract shall have their origin in countries other than those specified in the <b>PDS</b> .
7. Site Visit	7.1	The Consultant, at the Consultant's own responsibility, cost and risk, is encouraged to visit and examine the Site and obtain all information that may be necessary for preparing the Proposal and entering into a contract for Provision of Services.
	7.2	The Consultant should ensure that the PE is advised of the visit in adequate time to allow it to make appropriate arrangements.
	7.3	If specified in <b>PDS</b> , the Consultant's designated representative is invited to attend a site visit which, if convened, will take place at a place and on the date and time specified in the <b>PDS</b> . Unless specified in the <b>PDS</b> , non- attendance at the site visit will not be a cause for disqualification of a Consultant.

	8.2	The PE shall not be responsible for the completeness or incompleteness of the RFP and any addenda if they were not obtained directly from NeST.
	8.3	The Consultant is expected to examine all instructions, forms, terms, and provisions in the RFP. Failure to furnish all information or documentation required by the RFP may result in the rejection of the Proposal
9. RFP Clarification	9.1	A prospective Consultant requiring any clarification of the RFP may notify the PE through NeST not later than seven (7) calendar days prior to the deadline for the submission of Proposals.
	9.2	The PE shall within three (3) working days after receiving the request for clarification respond and publish through NeST provided that such request is received within time prescribed in ITC 9.1. The response shall include a description of the enquiry but without identifying its source.
	9.3	Should the PE deem necessary to amend the RFP as a result of a clarification, it shall do so following the procedure in ITC 11 [RFP Amendment].
10. Pre-proposal meeting.	10.1	To clarify issues and to answer questions on any matter arising in the RFP, the PE may, if stated in the <b>PDS</b> , invite prospective Consultants to a Pre-Proposal Meeting at the place, date and time as specified in the <b>PDS</b> . The Consultant is encouraged to attend the meeting if it is held.
	10.2	The Consultant may submit questions if any through NeST to reach the PE before the pre-proposal meeting. PE may respond to questions during the meeting, however, all questions raised and their responses will be transmitted in accordance with ITC 10.3.
	10.3	Minutes of the pre-proposal meeting, if applicable, including questions raised by the Consultants without identifying the source and the responses given, together with any responses prepared after the meeting will be transmitted within three (3) working days to all short-listed Consultants through NeST.
11. RFP Amendment	<b>11.1</b>	Any modification to the RFP Sections listed in ITC 8 [RFP Sections] that may become necessary as a result of the pre-Proposal meeting shall be made by the PE exclusively through the issue of an Addendum pursuant to this clause and not through the minutes of the Pre-Proposal meeting.
	11.2	At any time prior to the deadline for submission of Proposals, the PE, for any reason on its own initiative or in response to a clarification request from a Consultant, may amend the RFP by issuing an addendum.
	11.3	Any addendum including the notice of any extension of the deadline issued shall be the part of the RFP and shall be communicated through NeST to all the short-listed Consultants.
	11.4	In order to allow prospective Consultants reasonable time to take an addendum into account in preparing their Proposals, the PE at its discretion may extend the deadline for the submission of Proposals, pursuant to ITC 28 [Proposal

	11.5	Where PE decides to extend the submission date, the notice of any extension of the deadline shall be given promptly through NeST to Consultants to which the PE issued the RFP.

### C. Proposal Preparation

12. Only one Proposal	12.1	A short-listed Consultant, including its affiliate(s), may submit only one (1) Proposal. If a Consultant submits or participates in more than one (1) Proposal, all such proposals shall be rejected. This does not, however, preclude a sub-consultant, or the Consultant's Staff from participating as Key Experts and Non-Key Experts in more than one proposal when circumstances justify and if stated in the <b>PDS</b> .
13. Costs of Preparation of Proposal	13.1	The Consultant shall bear all costs associated with the preparation and submission of its Proposal, and the PE shall not be responsible or liable for those costs, regardless of the conduct or outcome of the procurement process
14. Proposal: Language	14.1	The Proposal, as well as all correspondences and documents relating to the Proposal and subsequent Contract, shall be written in the English language unless specified otherwise in the <b>PDS</b> . Supporting documents and printed literature furnished by the Consultant may be in another language provided they are accompanied by an accurate translation of the relevant passages in the English language or language specified in the <b>PDS</b> , in which case, for purposes of interpretation of the Proposal, such translation shall govern.
	14.2	The Consultant shall bear all costs of translation to the governing language and all risks of the accuracy of such translation
15. #### Scope of the Assignment

##### 4. Scope of the Assignment

The Consultant is expected to perform all the services required to achieve the objectives of the assignment in a fully professional manner and is required to adopt state of the art and the most economical and effective engineering concepts for the design works. In carrying out the work, the Consultant shall at all times co-operate with the client and keep them fully informed regarding the progress of all stages of the works. The Consultant shall carry out all the tasks necessary to achieve the defined objectives which shall include:

- a) Carry out a topographical survey of the Irrigation schemes potential area;
- b) Conduct Water Resource and Hydrological study;
- c) Conduct a soil survey;
- d) Conduct Agronomic study;
- e) Environmental and Social Impact Assessment Study (ESIA)
- f) Conduct Detail Engineering Design of Irrigation Infrastructures, farm structures, farm Roads and Drainage systems as well as flood protection Dyke if any;
- g) Carry out Geotechnical Investigations
- h) Carry out financial and economic analysis

##### a) Topographical Survey:

The consultant will be required to:

- i. Carry out topographical surveys to facilitate the location of permanent control points, structures, and computation of quantities of earthworks.
- ii. All topographic surveys undertaken by the Consultant shall be according to the Land Surveying and Mapping Standards of Tanzania, and shall be recorded in standard survey field books/electronic data book, which shall be submitted and become the property of the Client at the completion of the assignment.
- iii. Monumentation of all primary control points shall be made using 16mm steel pins embedded in 1.0m deep cast in-situ concrete. The description cards for the control points shall be prepared and submitted to the Client and detailed in the report to be submitted to the Client for future reference.
- iv. The Consultant shall liaise with the Ministry responsible for Lands for the existing National Grid/Datum reference beacons and benchmarks in order to establish the permanent control points. The co-ordinates of all intersection points shall be in the Universal Transverse Mercator (UTM) system and shall be tied to the National Survey Grid, and levels related to the National Benchmarks.



- v. The topographic data shall be available and presented on maps with a scale of 1:4000.
- vi. In addition, electronic copies of the topographic data saved in MS Excel and topographic drawings in DXF or DWG format shall be submitted in CD ROMs to the Client and become his property.
- vii. The Consultant shall carry out topographic map of the whole area as per actual scheme size.
- viii. Topographical Maps of potential access roads, site camp, and permanent housing area and construction facilities shall be prepared with a scale of 1:2000 and contour interval of 1.0meters.
- ix. The Consultant shall map the entire Project Area including upstream and downstream, potential communities, infrastructures and land use to be impacted by the project.
- x. The Consultant shall prepare aerial digital photography in full colour of the project area that will be used to produce geo referenced orthophoto mosaic maps of 1:5000 scales.
- xi. The following specifications are expected in this kind of activity:
  - a) Ground resolution: Pixel size (0.15-2m)
  - b) Digital terrain model with a 15 cm pixel with 15 cm spot height.
  - c) Spectral resolution: Visible channels red, green, or blue
  - d) For accurate determination of dwellings, affected properties /infrastructure, a resolution of 2 meters is preferred.
  - e) Geometrical accuracy: 2-5 m with control points.

- xii. Determine location of associated infrastructures including spillway and communities' settlement areas
- xiii. The Consultant shall survey with a grid system of 50 meters interval for Topographic map of the irrigable area (layout) and prepare maps at a scale of not more than 1:1000 a ta contour interval of not more than 1 meter for steep (25%) area and not more than 0.5m for plain and undulating areas shall be established, the topographic map should also show every major feature in the irrigable area - including traditional canals, water fetching points/springs, settlements, footpath and cattle crossings, gullies, trees, benchmarks, hills, graves; And
- xiv. The consultant will be required to identify the designed, developed and potential irrigable areas for the schemes

### **b) Hydrology and Water Resources**

The consultant will be required to:

- i. Assess the data quality available water runoff and rainfall data;
- ii. Carry flow measurement in the river at the proposed Weir site;
- iii. Quantify monthly runoff at different site location;
- iv. Adopt appropriate hydrological techniques to derive the required design flow including extreme river flow and hydrological statistic from the nearest available gauging station, where sufficient hydro-meteorological data are not available;
- v. Assess the spatial and season fluctuations of climatic variables on the hydrological characteristics of the project;
- vi. Undertake hydrological analysis to estimate reservoir yield, design floods to facilitate design and sizing of various hydraulic structures such as reservoir, spillway and outlet structures;
- vii. Determine the current and potential future water uses, including environmental flow and demand for the identified current water uses at the project area;
- viii. Propose an optimized water allocation scheme between various water users;

- ix. Determine sediment load including the projections of future changes in upstream sediments release based upstream development plan;
- x. Independently assess surface water availability at each irrigation intake point and determine the maximum and minimum discharges at the water intake structure considering issues of climate change and seasonal variability in the hydrological pattern for the region.;
- xi. Analyze water quality for irrigation from the identified water sources including a biological, physical, and chemical analysis of the water quality to determine suitability for use as irrigation water;
- xii. In the case for river flow diversion, assess the peak design flow with respect to the type of the water intake structure, temporary or permanent;
- xiii. Assess current water utilization levels on upstream and downstream and determine / recommend actual irrigation areas to be developed and/or extended based on available water resources and information on existing and future demands;
- xiv. Collect and analyze climate data to be used in the design of the irrigation schemes, where relevant, from the nearest reliable meteorological stations, to establish a historical series of most critical climate data, or where not available/relevant using monthly reference evapo-transpiration available for the agro-climatic zone and monthly precipitation with probability of exceedance of 80%;
- xv. Use standard statistical procedures for calculation of probable weather parameters used in the design of irrigation schemes including future climate scenarios, such as effective precipitation in the area;

### **c) Soil Survey Investigation**

The consultant will be required to:

- i. Undertake detailed soil survey in the demarcated irrigable command area, using appropriate sampling and observations in conformity with guidelines of soil survey from FAO;
- ii. Prepare soil survey map to a scale up to 1:10, 000 based on these surveys;

### **d) Agronomic Study**

- i. For optimal utilization of the available water supply, estimate scheme irrigation water requirements.

- iv. Crop production calendars for the selected cropping crops and cropping patterns.

- vi. Estimate of water conveyance and field irrigation water losses and determine the required peak design flow for the main, secondary and tertiary canals.

### **e) Environmental and Social Impact Assessment**

- i. To carry out comprehensive environmental and social Impact Assessment of the project as per the Environmental Management Act, No.20 of 2004 and its respective regulations, furthermore, incorporating the International Environmental and Social safeguards as well.

## **Background**

### **1.0 Introduction**

Mwanza Region is located in the Northern part of Tanzania along the shores of Lake Victoria which is the largest lake in Africa, the region lies between latitudes 1<sup>0</sup>30' and 3<sup>0</sup> South of the Equator and between longitudes 31<sup>0</sup>45' and 34<sup>0</sup>10' East of Greenwich. Geographically, The Region shares borders with Lake Victoria in the North, Kagera and Geita in the West, Mara region on the East while Shinyanga and Simiyu regions lies on the South and Southeastern parts of the region. Administratively, Mwanza region is divided into seven (7) districts namely Ukerewe, Magu, Mwanza, Kwimba, Sengerema, Ilemela, Misungwi and Buchosa.

Mwanza region in most parts experiences a bimodal rainfall pattern, the short rains falling from October to December and the long rains pours between March and May. While, dry periods spell from January to end of February and between June and end of September. The Region's average annual rainfall is about 930 mm, ranging between 1,200 mm in Ukerewe islands to 700 mm in the southern and southeastern parts of the Region. The temperature in the region is to some extent influenced by Lake Victoria, about 25<sup>0</sup>C – 28<sup>0</sup>C experienced between September and December and cool dry season last from June to August experiences low temperatures which range between 20<sup>0</sup>C and 11<sup>0</sup>C.

For the financial year 2023/2024, the Government of the United Republic of Tanzania has set aside fund for conducting feasibility studies and detailed engineering design for 18 irrigation schemes in Mwanza Region named; Mibungo (Ukerewe), Jojilo/ Mwamanga, Goloma, Nyamatala, Ngula, Mwitambu, Mwankulwe, Sumve Lugulu, Sumve (Kwimba), Nyashana Litel (Buchosa), Kandawe, Simiyu (Magu), Kiozu, Busegena (Ukerewe), Nyang`homango, Lubuga, Ukiliguru Research, Manawa (Misungwi) covering irrigable area approximated to 23,000

hectors.

Lack of irrigation infrastructures is the primary cause of the low crop yield and production in most of the areas. Therefore, there is a critical need for irrigation infrastructure development to address crop production issues. The Government of Tanzania (GoT) is dedicated to creating irrigation projects and related infrastructure, which will give local populations new economic prospects and change the course of the local economy.

**Project Description**

**2.0 Project Description**

Agriculture in Tanzania has remained unpredictable and of low productivity due to the utter dependence on rainfall, which is erratic, unreliable and non-uniformly distributed. This dependence on rain-fed agriculture has subjected crop production to be low due to the vagaries of weather. Consequently, the country has continued to suffer from frequent food shortages. It is widely accepted that, the currently increasing global warming and climate change, is having negative effects on the optimal availability of water resource for crop production worldwide including Tanzania. In this regard, Tanzania needs to improve irrigation infrastructures for efficient water utilization.

Irrigation development in Tanzania is critically important in ensuring that the abundant irrigation potential is covered with developed irrigation infrastructures for the purpose of crop irrigation, pasture as well as for aquaculture. This move will eventually lead to the nation to attain a reliable and sustainable crop production and productivity as a move towards food security and poverty reduction. For sustainable irrigation development, the intervention in irrigation development has verified worldwide that it increases crop production 3-4 times than that of rain-fed agriculture.

The Government of Tanzania (GoT) acknowledges that and committed to developing Irrigation Schemes in Mwanza Region, this will bring economic opportunities to communities in the area and transformation of local economies. **7.5 Land Surveyor Expert****Qualifications:**

The expert shall have documented experience in topographical land surveys and thematic mapping digital thematic and GIS based experience in similar large projects. He/she shall have a minimum BSc degree/Advanced Diploma qualification in land survey and have a minimum of 10 years overall experience and at least 5 years relevant GIS experience in similar assignments. He/ She must be conversant with the use of GNSS data collecting system and production of maps using AutoCAD Civil 3D software for the design of irrigation projects. He/She will perform the below tasks:

### **7.6 Environmental Specialist**

Safeguard or Environmental Specialist shall have a minimum of a master's degree in either Environment, Environmental engineering, Natural Resources Management, or related field and with at least cumulative experience of ten (10) years of practical working experience in undertaking ESIA studies or other related projects. In addition, He/ she must be familiar with the Tanzania Government Environmental laws and regulations, environmental policies and procedures and must be registered as EIA Expert with NEMC.

### **7.7 Agronomist**

#### **Qualification;**

The expert should have a degree/ Advanced diploma with at least five professional experiences in at least four (4) projects in Assessing of Land Use and Irrigated Agronomy on Schemes Area

**Responsibility:** The expert will cover the following: -

- a) For optimal utilization of the available water supply, estimate scheme irrigation water requirements.
- b) Together with farmers, identify and promote the production of high-yielding, labor-absorbing, and high-value crop varieties including rice, fruits, vegetables, green maize and spices as the weather and soil conditions may allow.
- c) The socio-economic implications of the identified crops, including the extent to which their cultivation might be expected to absorb rural labour, rather than expelling it.
- d) Crop production calendars for the selected cropping crops and cropping patterns.
- e) Develop site specific guidelines for irrigation scheduling of all the selected crops to be grown in the designed irrigation scheme.
- f) Estimate of water conveyance and field irrigation water losses and determine the required peak design flow for the main, secondary and tertiary canals.
- g) Assess land use practices and recommend management practice that will be useful to control land degradation;



- h) Assess livestock occurrence within the project area, livestock management practice and carrying capacity of the land, and how this will conflict or be compatible with irrigation development;
- i) Analyze with a gender lens, the land tenure and current land use activities and levels of production; this should include use for agricultural activities, livestock, forestry and how they will be affected by proposed irrigation interventions;
- j) Identify and promote the production of climate resilient, high yielding and high value crop varieties for each individual site, wherever possible and together with farmers and extension agronomist;
- k) Determine water requirements for the crops and cropping patterns selected for optimal utilization of the available water supply. In carrying out this task, collaboration between the design engineer and agronomist would be essential;

# GENERAL CONDITIONS OF THE CONTRACT

## A. Preliminary Clauses

<b>2. Interpretation of Contract Documents</b>	2.1	In interpreting these conditions of contract headings and marginal notes are used for convenience only and shall not affect the interpretations unless specifically stated; References to singular includes plural and vice versa; and masculine include the feminine. Words have their ordinary meaning under the language of the contract unless specifically defined.
	2.2	Subject to the order of precedence set forth in the form of contract, all documents forming the Contract (and all parts) are intended to be correlative, complementary, and mutually explanatory.
<b>3. Corrupt, Fraudulent, Collusive or Coercive Practices</b>	3.1	The Government requires that Clients, as well as Consultants shall observe the highest standard of ethics during the implementation of procurement proceedings and the execution of contracts under public funds.
	3.2	In pursuance of this requirement, the Client shall: (a) exclude the Consultant from participation in the procurement proceedings concerned or reject a proposal for award; and (b) declare the Consultant ineligible, either indefinitely or for a stated period of time, from participation in procurement proceedings under public fund; if it at any time determines that the Consultant has, directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for, or in executing, a contract under public fund.
	3.3	Should any corrupt or fraudulent practice of any kind referred to in GCC 3.4 come to the knowledge of the Client, it shall, in the first place, allow the Consultant to provide an explanation and shall take actions as stated in GCC 3.2 only when a satisfactory explanation is not received. Such exclusion and the reasons, therefore, shall be recorded in the record of

		the procurement proceedings and promptly communicated to the Consultant concerned. Any communications between the Consultant and the Client related to matters of alleged fraud or corruption shall be in writing or in electronic forms that provide record of the content of the communication.

	3.5	The parties agree that their personnel have an equal obligation not to solicit, ask for and/or use coercive methods to obtain personal benefits in connection with the said proceedings.
4. Interpretation	4.1	<p><u>Entire Contract</u></p> <p>The Contract constitutes the entire agreement between the Client and the Consultant and supersedes all communications, negotiations and agreements (whether written or oral) of parties with respect thereto made prior to the date of Contract.</p>
	4.2	<p><u>Amendment</u></p> <p>No amendment or other variation of the Contract shall be valid unless it is in writing or in electronic forms that provide record of the content of the communication, is dated, expressly refers to the Contract, and is signed by a duly authorized representative of each party thereto.</p>
	4.3	<p><u>Non-waiver</u></p> <p>a) Subject to GCC 4.3 (b) below, no relaxation, forbearance, delay, or indulgence by either party in enforcing any of the terms and conditions of the Contract or the granting of time by either party to the other shall prejudice, affect, or restrict the rights of that party under the Contract, neither shall any waiver by either party of any breach of Contract operate as waiver of any subsequent or continuing breach of Contract.</p> <p>(b) Any waiver of a party’s rights, powers, or remedies under the Contract must be in writing or in electronic forms that provide record of the content of the communication, dated, and signed by an authorized representative of the party granting such waiver, and must specify the right and the extent to which it is being waived.</p>

	4.5	<u>Phased completion</u> If phased completion is indicated in the SCC, references in the GCC to the Services, the Completion Date, and the Intended Completion Date apply to any Phase of the Services (other than references to the Completion Date and Intended Completion Date for the whole of the Services).
<b>5. <b>6. Eligibility</b>	6.1	The Consultant and its Sub-Consultants shall have the nationality of a country, other than stated in SCC.
	6.2	All materials, equipment, plant, and supplies used by the Consultant and services supplied under the Contract shall have their origin in the countries, except stated in the SCC.
<b>7. Governing Language</b>	7.1	The Contract as well as all correspondence and documents relating to the Contract exchanged between the Consultant and the Client, shall be written in the English language unless otherwise in stated in SCC.  Supporting documents and printed literature that are part of the Contract may be in another language provided these are accompanied by an accurate translation of the relevant passages in English, in which case, for purposes of interpretation of the Contract, this translation shall govern.
	7.2	The Consultant shall bear all costs of translation to the governing language and all risks of the accuracy of such translation.
<b>8. Applicable Law</b>	8.1	The Contract shall be governed by and interpreted in accordance with the laws of Tanzania.
<b>9. Contractual Ethics</b>	9.1	No fees, gratuities, rebates, gifts, commissions or other payments, other than those shown in the proposal or the contract, shall have been given or received in connection with the selection process or in the contract execution.
<b>10. Joint Venture,</b>	10.1	If the Consultant is a Joint Venture, consortium, or association, (this

<b>Consortium or Association (JVCA)</b>		does not include sub consultancy) all of the parties shall sign the Contract Agreement and be jointly and severally liable to the Client for the fulfilment of the provisions of the Contract and shall designate one party to act as a Member-in-Charge with authority to bind the joint venture, consortium, or association. The composition or the constitution of the Joint Venture, consortium, or association shall not be altered without the prior consent of the Client.
<b>11. Communications and Notices</b>	11.1	Communications between Parties (notice, request or consent required or permitted to be given or made by one party to the other) pursuant to the Contract shall be in writing or in electronic forms that provide record of the content of the communication to the addresses indicated. Details of the Consultant's address will be available in the Contract Finalization Information Section in the Contract Agreement.
	11.2	A notice, request or consent shall be effective when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent to such Party at the address specified in the GCC 11.1.
	11.3	A Party may change its address for notice hereunder by giving the other Party notice of such change to the address specified.
<b>12. Assignment</b>	12.1	Neither the Client nor the Consultant shall assign, in whole or in part, their obligations under this Contract.
<b>13. Relation between the Parties</b>	13.1	Nothing contained herein shall be construed as establishing a relation of master and servant or of principal and agent as between the Client and the Consultant. The Consultant, subject to this Contract, has complete charge of Personnel and Sub-Consultants, if any, performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.
<b>14. Site</b>	14.1	The Services shall be performed at such locations as indicated in SCC or as indicated in Appendix 1, to the Contract and, where the location of a particular task is not so specified, at such locations as the Client may approve.
<b>15. Authority of Member in Charge</b>	15.1	In case the Consultant consists of a JVCA of more than one entity, the Members hereby authorize the Member in Charge who shall act on their behalf in exercising all the Consultant's rights and obligations towards the Client under this Contract, including without limitation the receiving of instructions and payments from the Client. Details of the authorized member will be available in the Contract Finalization Information Section in the Contract Agreement.
<b>16. Authorized Representatives</b>	16.1	Any action required or permitted to be taken, and any document required or permitted to be executed under this Contract by the Client or the Consultant may be taken or executed by duly authorized representatives. Details of the Client's Authorized Representative will be available in the Contract Finalization Information Section in the Contract Agreement.
<b>17. Taxes and Duties</b>	17.1	The Consultant, Sub-Consultants and their Personnel shall pay such taxes, duties, fees and other impositions as may be levied under the Governing Law, the amount of which is deemed to have been included in the Contract Price.

## B. Commencement, Completion, and Modification of Contract

<b>18. Effectiveness of Contract</b>	18.1	The Contract shall come into force and effect on the date (the “Effective Date”) of the Client’s notice to the Consultant instructing the Consultant to begin carrying out the Services. This notice shall confirm that the effectiveness conditions, if any as indicated in SCC have been met.
<b>19. Termination of Contract for Failure to Become Effective</b>	19.1	If the Contract has not become effective within such time period after the date of the Contract signature by the Parties as specified in SCC, either Party may, by not less than twenty-one (21) days written notice to the other Party, declare this Contract to be null and void, and in the event of such a declaration by either Party, neither Party shall have any claim against the other Party with respect hereto.
<b>20. Commencement of Services</b>	20.1	The Consultant shall begin carrying out the Services not later than the number of days after the Effective Date that specified in SCC.
<b>21. Expiration of Contract</b>	21.1	Unless terminated earlier pursuant to GCC 66 [Termination for Default], GCC 67 [Termination for Insolvency], GCC 68 [Termination for Convenience], and GCC 69 [Termination because of Force Majeure], this Contract shall expire at the end of such time period after the Effective Date that is stated in SCC.
<b>22. Modifications or Variations</b>	22.1	Any modification or variation of the terms and conditions of the Contract, including any modification or variation of the Scope of the Services, may only be made by written agreement between the Parties. Pursuant to GCC 51.1 [Payments General], however, each Party shall give due consideration to any proposals for modification or variation made by the other Party.

### C. Consultant's Personnel and Sub-Consultants

<b>23. General</b>	23.1	The Consultant shall employ and provide such qualified and experienced Personnel and Sub Consultants as are required to carry out the Services.
<b>24. Description of Personnel</b>	24.1	The title agreed job description, minimum qualification, and estimated period of engagement in the carrying out of the Services of each of the Consultant's Key Personnel are described in Appendix 2, to the contract. If any of the Key Personnel has already been approved by the Client's name shall be listed in Appendix 2.
	24.2	<p>If required to comply with the provisions of GCC 27 [Removal and/or Replacement of Personnel], adjustments with respect to the estimated periods of engagement of Key Personnel set forth in Appendix 2 to the contract may be made by the Consultant by written notice to the Client, provided:</p> <ul style="list-style-type: none"> <li>(a) that such adjustments shall not alter the original estimated period of engagement of any individual by more than 10% or one week, whichever is the larger;</li> <li>(b) that the aggregate of such adjustments shall not cause payments under this Contract to exceed the ceilings set forth in GCC 50.2 [Cost Estimate of Services; Ceiling Amount]; and</li> <li>(c) any other such adjustments shall only be made with the Client's written approval.</li> </ul>
	24.3	If additional work is required beyond the Scope of the Services specified in Appendix 1 to the contract, the estimated periods of engagement of Key Personnel set forth in Appendix 2 may be increased by agreement in writing or in electronic forms that provide a record of the content of the communication between the Client and the Consultant. In case that will cause payments under the Contract to exceed the ceilings set forth in GCC 50.2 [Ceiling Amount] of this Contract, this will be explicitly in the Contract.
<b>25. Approval of Personnel</b>	25.1	The Client hereby approves the Key Personnel and Sub Consultants listed by title as well as by name in Appendix 2 to the contract. In respect of other Personnel that the Consultant proposes to use in the carrying out of the Services, the Consultant shall submit to the Client for review and approval a copy of their Curricula Vitae (CVs). If the Client does not object in writing or in electronic forms that provide record of the content of the communication (stating the reasons for the objection) within twenty-one (21) days from the date of receipt of such CVs, such Personnel shall be deemed approved by the Client.
<b>26. Working Hours, Overtime, Leave &amp; Holidays</b>	26.1	Working hours and holidays, entitlement of leave and overtime, etc. for Key Personnel are set forth in Appendix 3 to the Contract.
	26.2	The Key Personnel shall not be entitled to be paid for overtime nor to take paid sick leave or vacation leave, except as specified in Appendix 3 to the contract and except as specified in such Appendix 3, the Consultant's remuneration shall be deemed to cover these items.
<b>27. Removal and/or Replacement of Personnel</b>	27.1	Except as the Client may otherwise agree, no changes shall be made in the Personnel. If, for any reason beyond the reasonable control of the Consultant, it becomes necessary to replace any of the Personnel, the Consultant shall forthwith provide as a replacement a person of equivalent or better qualifications acceptable to the Client.

	27.2	<p>If the Client</p> <ul style="list-style-type: none"> <li>(a) finds that any of the Personnel has committed serious misconduct or has been charged with having committed a criminal action; or</li> <li>(b) has reasonable cause to be dissatisfied with the performance of any of the Personnel,</li> </ul> <p>then the Consultant shall, at the Client's written request specifying the grounds therefore, forthwith provide as a replacement a person with qualifications and experience acceptable to the Client.</p>
	27.3	<p>In the event that any Sub-Consultant is found by the Client to be incompetent or incapable of discharging the assigned duties, the Client may request and the Consultant shall provide a replacement, with qualifications and experience acceptable to the Client, or to resume the performance of the Services itself.</p>
	27.4	<p>Any of the Personnel provided as a replacement under GCC 27.1 and 27.2, the rate of remuneration applicable to such person as well as any reimbursable expenses, the Consultant may wish to claim as a result of such replacement, shall be subject to the prior written approval by the Client. <b>28. Project Manager</b>	28.1	<p>The Consultant shall ensure that at all times during the Consultant's performance of the Services a Project Manager, acceptable to the Client, shall take charge of the operations of the personnel and performance of such Services.</p>

### D. Obligations of the Consultant

<b>29. Standard of Performance</b>	29.1	<p>The Consultant shall perform the Services and carry out its obligations hereunder with all due diligence, efficiency and economy, in accordance with generally accepted professional standards and practices, and shall observe sound management practices, and employ appropriate technology and safe and effective equipment, machinery, materials and methods. The Consultant shall always act, in respect of any matter relating to this Contract or to the Services, as faithful advisers to the Client, and shall at all times support and safeguard the Client's legitimate interests in any dealings with Sub Consultants or Third Parties.</p>
<b>30. Law Governing Services</b>	30.1	<p>The Consultant shall perform the Services in accordance with the Applicable Law and shall take all practicable steps to ensure that any Sub Consultants, as well as the Personnel of the Consultant and any Sub Consultants, comply with the Applicable Law.</p>
<b>31. Conflict of Interests</b>	31.1	<p>The Consultant shall hold the Client's interests paramount, without any consideration for future work, and strictly avoid conflict with other assignments or their own corporate interests.</p>
<b>32. Consultant Not to Benefit from Commissions, Discounts</b>	32.1	<p>The Consultant shall not accept for their own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Contract or in the discharge of their obligations hereunder, and the Consultant shall use their best efforts to ensure that any Sub Consultants, as well as the Personnel and agents of either of them, similarly shall not receive any such additional remuneration.</p>
	32.2	<p>Furthermore, if the Consultant, as part of the Services, have the responsibility of advising the Client on the procurement of goods, works or services, the Consultant shall at all times exercise such responsibility in the best interest of the Client. Any discounts or commissions obtained by the Consultant in the exercise of such procurement responsibility shall be for the account of the Client.</p>
<b>33. Consultant and Affiliates not to Engage in Certain Activities</b>	33.1	<p>The Consultant agrees that, during the term of this Contract and after its termination, the Consultant and any entity affiliated with the Consultant, as well as any Sub-Consultant and any entity affiliated with such Sub-Consultant, shall be disqualified from providing goods, works or services (other than consulting services) for any project resulting from or closely related to the Services.</p>
<b>34. Prohibition of Conflicting Activities</b>	34.1	<p>The Consultant shall not engage, and shall cause their Personnel as well as their Sub-Consultants and their Personnel not to engage, either directly or indirectly, in any business or professional activities in Tanzania that would conflict with the activities assigned to them under this Contract.</p>
<b>35. Confidentiality</b>	35.1	<p>Except with the prior written consent of the Client, the Consultant and the Personnel shall not at any time communicate to any person or entity any confidential information acquired in the course of the Services, nor shall the Consultant and the Personnel make public the recommendations formulated in the course of, or as a result of, the Services. For purposes of this section, "confidential information" means any information or knowledge acquired by the Consultant and/or their Personnel arising out of, or in connection with, the performance of the Services under this Contract that is not otherwise available to the public.</p>

<b>36. Liability of the Consultant</b>	36.1	The Consultant shall be responsible for, and shall indemnify the Client, in respect of loss of or damage to equipment and materials furnished by the Client, or purchased by the Consultant in whole or in part with funds provided by the Client.
	36.2	The Consultant undertakes full responsibility in respect of life, health, and accidents for the Personnel.
	36.3	The Consultant shall indemnify the Client from and against any and all claims, liabilities, obligations, losses, damages, penalties, actions, judgment, suits, proceedings, demands, costs, expenses and disbursements of whatsoever nature that may be imposed on, incurred by or asserted against the Client during or in connection in the Services by reason of: <ul style="list-style-type: none"> <li>(a) infringement or alleged infringement by the Consultant of any patent or other protected right; or</li> <li>(b) plagiarism or alleged plagiarism by the Consultant.</li> </ul>
	36.4	The Consultant shall ensure that all goods and services (including but without limitation to all computer hardware, software and systems) procured by the Consultant out of funds provided or reimbursed by the Client or used by the Consultant in the carrying out of the Services do not violate or infringe any industrial property or intellectual property right or claim of any third party.
	36.5	The Consultant shall indemnify, protect and defend at their own expense the Client, and its agents and employees from and against any and all actions, claims, losses or damages arising out of Consultant's failure to exercise the skill and care required under GCC 29 [Standard of Performance] provided: <ul style="list-style-type: none"> <li>(a) that the Consultant is notified of such actions, claims, losses or damages not later than the period indicated in the SCC after conclusion of the Services.</li> <li>(b) that the ceiling on the Consultant's liability under GCC 29 shall be limited to the amount indicated in the SCC, except that such ceiling shall not apply to actions, claims, losses or damages caused by Consultant's gross negligence or reckless conduct; and</li> <li>(c) that the Consultant's liability under GCC 29 shall be limited to actions, claims, losses or damages directly caused by such failure to exercise the said skill and care, and shall not include liability for any actions, claims, losses or damages arising out of occurrences incidental or indirectly consequential to such failure.</li> </ul>
	36.6	In addition to any liability the Consultant may have under GCC 29, the Consultant shall, at their own cost and expense, upon request of Client, re-perform the Services in the event of Consultant's failure to exercise the skill and care required under GCC 29.
	36.7	Notwithstanding the provisions of GCC 36.1, the Consultant shall have no liability whatsoever for actions, claims, losses or damages occasioned by: (i) Client's overriding a decision or recommendation of the Consultant or requiring the Consultant to implement a decision or recommendation with which Consultant do not agree; or (ii) the improper execution of the Consultant's instructions by agents, employees or independent contractors of the Client.

Our contract requires us to implement measures to address environmental and social risks related to the Services, including the risks of sexual exploitation, sexual abuse and sexual harassment.

This Code of Conduct is part of our measures to deal with environmental and social risks related to the Services. It applies to all Experts in places where the Services are being carried out.

This Code of Conduct identifies the behavior that we require from all Experts.

Our workplace is an environment where unsafe, offensive, abusive or violent behavior will not be tolerated and where all persons should feel comfortable raising issues or concerns without fear of retaliation.

#### REQUIRED CONDUCT

Experts shall:

1. Carry out his/her duties competently and diligently;
2. Comply with this Code of Conduct and all applicable laws, regulations and other requirements, including requirements to protect the health, safety and well-being of other Experts and any other person;
3. Maintain a safe working environment including, as applicable, by:
  - a. ensuring that workplaces, equipment and processes under each person's control are safe and without risk to health;
  - b. wearing required personal protective equipment; and
  - c. following applicable emergency operating procedures.
4. Report work situations that he/she believes are not safe or healthy and remove himself/herself from a work situation which he/she reasonably believes presents an imminent and serious danger to his/her life or health;
5. Treat other people with respect, and not discriminate against specific groups such as women, people with disabilities, migrant workers or children;
6. Not engage in Sexual Harassment, which means unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature with other Experts, Contractor's Personnel (if applicable) or Client's Personnel;
7. Not engage in Sexual Exploitation, which means any actual or attempted abuse of position of vulnerability, differential power or trust, for sexual purposes, including, but not limited to, profiting monetarily, socially or politically from the sexual exploitation of another;
8. Not engage in Sexual Abuse, which means the actual or threatened physical intrusion of a sexual nature, whether by force or under unequal or coercive conditions;
9. Not engage in any form of sexual activity with individuals under the age of 18, except in case of pre-existing marriage;

10. Complete relevant training courses that will be provided related to the environmental and social aspects of the Contract, including on health and safety matters, Sexual Exploitation and Abuse (SEA), and Sexual Harassment (SH);
11. Report violations of this Code of Conduct; and
12. Not retaliate against any person who reports violations of this Code of Conduct, whether to us or the Client, or who makes use of grievance mechanism for Experts, if any, or the project's Grievance Redress Mechanism.

**RAISING CONCERNS**

If any person observes behavior that he/she believes may represent a violation of this Code of Conduct, or that otherwise concerns him/her, he/she should raise the issue promptly. This can be done in either of the following ways:

1. Contact [*enter name of the Consultant's social expert with relevant experience in handling sexual exploitation, sexual abuse and sexual harassment cases, or if such person is not required under the Contract, another individual designated by the Consultant to handle these matters*] in writing at this address [ ] or by telephone at [ ] or in person at [ ]; or

The person's identity will be kept confidential, unless reporting of allegations is mandated by the country law. Anonymous complaints or allegations may also be submitted and will be given all due and appropriate consideration. We take seriously all reports of possible misconduct and will investigate and take appropriate action. We will provide warm referrals to service providers that may help support the person who experienced the alleged incident, as appropriate.

There will be no retaliation against any person who raises a concern in good faith about any behavior prohibited by this Code of Conduct. Such retaliation would be a violation of this Code of Conduct.

**CONSEQUENCES OF VIOLATING THE CODE OF CONDUCT**

Any violation of this Code of Conduct by Experts may result in serious consequences, up to and including termination and possible referral to legal authorities.

**ATTACHMENT 1 TO THE CODE OF CONDUCT FORM**

**BEHAVIORS CONSTITUTING SEXUAL EXPLOITATION AND ABUSE (SEA) AND BEHAVIORS CONSTITUTING SEXUAL HARASSMENT (SH)**

The following non-exhaustive list is intended to illustrate types of prohibited behaviors:



(1) **Examples of sexual exploitation and abuse** include, but are not limited to:

- An Expert tells a member of the community that he/she can get them jobs related to the Services (e.g. cooking and cleaning) in exchange for sex.
- An Expert that is connecting electricity in put to households says that he can connect women headed households to the grid in exchange for sex.
- An Expert rapes, or otherwise sexually assaults a member of the community.
- An Expert denies a person access to the Site unless he/she performs a sexual favor.
- An Expert tells a person applying for employment under the Contract that he/she will only hire him/her if he/she has sex with him/her.

(2) **Examples of sexual harassment in a work context**

- An Expert comment on the appearance of another Expert (either positive or negative) and sexual desirability.
- When An Expert complains about comments made by another Expert on his/her appearance, the other Expert comment that he/she is “asking for it” because of how he/she dresses.
- Unwelcome touching of an Expert or Client’s Personnel by another Expert.
- An Expert tells another Expert that he/she will get him/her a salary raise, or promotion if he/she sends him/her naked photographs of himself/herself.
